

General Terms and Conditions

§1 General Scope

(1) The General Terms and Conditions (hereinafter referred to as "GTC") govern the sale of Products by Stéphanie Boisset (hereinafter "Supplier") to you, in the version valid at the time of the order.

(2) Different terms and conditions of the customer are rejected

(3) Please read these terms carefully before placing an order with Stéphanie Boisset. By placing an order with Stéphanie Boisset, you agree to the application of these Terms and Conditions to your order.

(4) On artproof, Stéphanie Boisset offers to sell the following selected fine art prints of her photographic work:

- Books, self-published, limited edition, numbered and signed.
- Handmade Black&White prints from negative on fiber paper in limited edition, numbered and signed.
- Photograms on fiber paper - single copie signed.
- Color photographs (pigment prints) in limited edition, numbered and signed.

§2 Conclusion of the contract

(1) The presentation and description of books, photographic and fine art prints on the website www.artproof.de does not represent a contract offer, but is only non-binding requests to the customer to place an order. The online representations may differ slightly from the ordered artwork / prints.

Especially the color rendering is technically not 100% reliable.

(2) By ordering a product by clicking on the button "Send order" at the end of the order process, a consumer makes a binding offer on a purchase contract. Only with the dispatch of an order confirmation by e-mail by the user, the contract is concluded.

(3) Upon receipt of the order of a product following rules apply: The consumer makes a binding contract offer by successfully going through the order procedure

provided in my Internet shop.

The order is made in the following steps:

Selection of the desired product. Add to cart by clicking on the icon "Add to cart".

1. Checking the details in the shopping cart.
2. Operation of the button "to checkout".
3. Enter customer data (billing address or other delivery address), order as a guest or create a customer account (in this case, a password will be automatically generated and sent to the specified e-mail address.) For security reasons, it is recommended to change this password when logging in for the first time).
4. Re-examination of the order.
5. Choose payment options.
6. Agree to terms and conditions.
7. Binding dispatch of the order by clicking on the button "send order" or "buy".

(4) The consumer can return to the website, on which the information of the customer are recorded and correct input errors before the binding sending of the order by pressing the "back" button contained in the Internet browser used by him after checking his information or cancel the order process by closing the Internet browser. I confirm the receipt of the order directly by an automatically generated e-mail ("order confirmation"). With this I accept your offer.

(5) Storage of the contract text for orders via my Internet shop: I save the contract text and send you the order data and our terms and conditions by e-mail. You can also view the terms and conditions at www.artproof.de/agb.html at any time.

§3 prices and shipping costs

(1) The statutory sales tax and other price components are included in the prices quoted. Shipping costs are not included in the displayed price and may be additional.

(2) Despite my best efforts, a small number of the products in my portfolio may be priced incorrectly. I check the prices when I process your order and before I charge the payment. If a product is priced incorrectly and the correct price is higher than the price on the website, I will contact you before shipping the product to ask you if you would like to buy the product at the correct price or cancel the order. If the correct price of a product is lower than the price I have specified, I will charge the lower amount and send you the product.

(3) The prices are valid at the time of the order. If list prices are available, the prices of the list price valid at the time of ordering apply.

§4 payment

\$5 delivery

(1) Unless I have clearly indicated otherwise in the product description, all deductions offered by me are immediately ready for shipment. Orders are always shipped on Thursdays, if the order has been placed before 23:59 on Wednesday. The delivery method pickup means that we have to make an appointment.

(2) The risk of accidental loss and accidental deterioration of the sold item shall not be transferred to the buyer until the goods have been handed over to the buyer.

(3) Stéphanie Boisset sends her photographs and books in the following countries:

- Germany
- European Union: Belgium, Bulgaria, Denmark, Estonia, Finland, France, Greece, Ireland, Italy, Croatia, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Austria, Poland, Portugal, Romania, Sweden, Slovakia, Slovenia, Spain, Czech Republic, Hungary, Cyprus.
- Europe (not EU): Iceland, Liechtenstein, Norway, Switzerland, United Kingdom.
- Worldwide: USA, Canada, Australia, New Caledonia, New Zealand, Japan,

South Korea.

(4) Each order will be sent as a letter by registered letter / letter or book mail to Germany and registered mail International / Recommandé or book mail abroad with the German Post.

When sent by registered mail, the deliverer will personally hand over the consignment only against signature to the recipient or a recipient.

§6 Customs

(1) If you order photographs or books from artproof, Stéphanie Boisset's portfolio, for delivery outside the European Union, you may be subject to import duties and taxes, which will be levied once the letter reaches the designated destination. Any additional fees for customs clearance must be borne by you; we have no control over these charges. Customs regulations vary greatly from country to country, so you should contact your local customs office for more information.

(2) Please also note that if you order from artproof, Stéphanie Boisset's portfolio, you will be considered an initiator and must comply with all laws and regulations of the country in which you receive the products. Protecting your data is important to me and I would like to draw my international customers' attention to the fact that cross-border deliveries are subject to opening and investigation by customs authorities.

§7 Retention of title

Stéphanie Boisset retains title to the goods until full payment of the purchase price.

§8 Right of withdrawal of the customer as a consumer

Withdrawal for a consumer

Consumers are entitled to a right of withdrawal according to the following conditions, whereby the consumer is any natural person who concludes a legal

transaction for purposes which are predominantly neither commercial nor self-employed:

Withdrawal

You have the right to withdraw from this contract within fourteen days without giving any reason.

The cancellation period is fourteen days from the date on which you or a third party named by you, who is not the carrier, has or has taken possession of the goods.

To exercise your right of withdrawal, you must provide a clear statement (such as a letter sent by post or e-mail) of your decision to withdraw from this contract. You can use the attached model withdrawal form, which is not required.

Consequences of Withdrawal

If you withdraw from this Agreement, I will have you all the payments I have received from you, including the delivery charges (except for the additional costs arising from choosing a different type of delivery than the cheapest standard delivery I offer) have to repay immediately and at the latest within fourteen days from the date on which the notification of your revocation of this contract has reached me.

For this repayment, I will use the same means of payment you used in the original transaction, unless otherwise expressly agreed with you. In no case will you be charged for this repayment fees.

I can refuse to repay you until I have the goods back or until you have provided proof that you have returned the goods, whichever is the earlier.

You must return the goods to us immediately and in any event not later than

fourteen days from the date on which you inform us of the cancellation of this contract. The deadline is met if you send the goods before the expiry of the period of fourteen days.

You bear the immediate costs of returning the goods.

§10 warranty

The buyer is obliged to check the delivered goods immediately upon receipt and to report any complaints within fourteen days in writing. The warranty on delivered goods includes defects which are demonstrably based on faulty material or defective processing. In case of complaints, the date of purchase must be proven with an invoice.

Excluded are defects caused by transport, improper handling, alteration of the delivered item or natural wear. Customary or minor, technically unavoidable deviations in quality, color, size, print, equipment or design must not be objected to. If a delivery item is faulty or lacks promised properties, the seller shall make a substitute under the exclusion of any other warranty claims in the event of timely complaint. The seller has the right to multiple replacement or repair. If a replacement or a subsequent improvement is not possible, then the buyer has the possibility to convert the purchase contract (undo) or to reduce (reduce the purchase price). Regardless of the legal reason, the liability of the seller is limited to the amount of the delivery price.

§ 11 Privacy

(1) If personal data (such as name, address, e-mail address) are collected, I undertake to obtain your prior consent. I agree not to disclose any information to third parties unless you have previously consented.

(2) I point out that the transmission of data on the Internet (eg via e-mail) can have security gaps. Accordingly, error-free and trouble-free protection of third-party data can not be fully guaranteed. In this regard, my liability is excluded.

(3) Third parties are not entitled to use contact data for commercial activities, provided the provider has previously given the persons concerned written consent.

(4) You have the right at any time to obtain information from artproof.de about

the data relating to you completely and free of charge. The following personal information will be kept for as long as it is needed for processing.

(5) Furthermore, there is a right to correction / deletion of data / restriction of processing for the user.

(6) Further information on data protection can be found in the separate privacy policy.

§ 12 Cookies

(1) To display the product offer, it may happen that I use cookies. Cookies are small text files stored locally in the cache of the site visitor's Internet browser.

(2) Many websites and servers use cookies. Many cookies contain a so-called cookie ID. A cookie ID is a unique identifier of the cookie. It consists of a string through which Internet pages and servers can be assigned to the specific Internet browser in which the cookie was stored. This allows visited websites and servers to distinguish the individual's browser from other Internet browsers that contain other cookies. A particular Internet browser can be recognized and identified by the unique cookie ID.

(3) Through the use of cookies, users of this website can provide more user-friendly services that would not be possible without the setting of cookies.

(4) I point out that some of these cookies are transferred from my server to your computer system, which are mostly session-based cookies. Session-related cookies are characterized by the fact that they are automatically deleted from your hard disk after the end of the browser session. Other cookies remain on your computer system and allow us to recognize your computer system on your next visit (so-called persistent cookies).

(5) You may object to the storage of cookies, for this you have a banner at your disposal which you can refuse / accept.

(6) Of course, you can set your browser so that no cookies are stored on the hard drive or already stored cookies are deleted again. The instructions for the

prevention and deletion of cookies can be found in the help function of your browser or software manufacturer.

§13 Final provisions

(1) Contract language is German.

(2) I do not offer products for sale by minors. If you are under 18, you may use my online store only with the assistance of a parent or legal guardian.

(3) I reserve the right to make changes to my website, policies, conditions including these terms and conditions at any time. Your order will be subject to the Terms of Sale, Terms and Conditions of Use in force at the time of your order, unless any change to these terms is required by law or governmental authority (in which case they will apply to orders placed by you) You have done before). If any provision of these Terms of Sale is ineffective, void or for any reason unenforceable, then this provision shall be deemed severable and shall not affect the validity and enforceability of the remaining provisions.

(4) The ineffectiveness of a provision does not affect the validity of the other provisions of the contract. If this occurs, the provision shall be replaced by another legally permissible provision which corresponds to the purpose of the invalid provision.
